- Increase in funding of the healthcare modernization programs in the Eurasian economic union countries in particular and in the world in general.

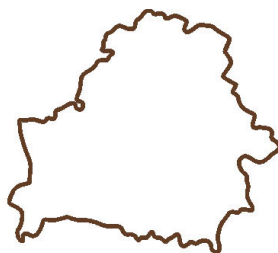

* applicable to profits received from the sale of goods (works, services) of own productions for export and to other residents of the FEZ

FEZ residents are exempt from payment of customs duties on import of raw materials and equipment into territory of free customs zone, which is determined for each resident individually.

Land Tax is not paid for the land plots within the boundaries of FEZ.

FEZ residents are exempt from payment of customs duties on produced goods in case of sale outside Eurasian economic union countries.
